


## Funding windows adapted to the needs of the funding body

#### **Customized regarding:**

- Geography (global, regions, countries)
- PtX-product selection
- Product and sustainability criteria

#### Adaptable to targets:

- Price optimization
- Promotion of green technology
- Energy policy
- Decarbonization of specific sectors
- Development policy



## **Modular system** BMWK grant notification in the amount of 900 million euros

#### Geography\*

- Competition-based purchasing beyond EU and EFTA; delivery to Germany and Europe.
- Competition-based sale to German and European companies; awarded to the highest bidder.

#### **Products produced based on green H2\***

• Ammonia, methanol, jet fuel.

#### Criteria\*

- Electricity from additional renewable sources must be used for production.
- Criteria for electricity purchase, greenhouse gas balancing and CO2 sourcing are to be oriented towards REDII.
- Emission savings of the product shall be at least 70% according to Art. 25 para.
  2 of the Renewable Energy Directive.






